Cllr. Patrick McKee, Chairman - opened the meeting and welcomed all in attendance.

Item No. 1: Confirmation of Minutes of Meeting held on 23<sup>rd</sup> September, 2015.

#### **Matters Arising**

Cllr. Melissa O'Neill requested that the Council's Anti-Social Behaviour Policy be placed on the Agenda for discussion by the Joint Policing Committee. Cllr. Patrick McKee advised that following discussion by the Joint Policing Committee Steering Group it was agreed that the Housing SPC is the forum for discussion on this Policy. It was:

This motion was put to a vote, by a show of hands, and was passed by four votes to two in favour of the motion.

### Item No. 2: Report by JPC Chairman on JPC Steering Committee held on 5<sup>th</sup> May, 2016.

Cllr. Patrick McKee outlined to the meeting the membership of the JPC Steering Committee and advised that a meeting of the Committee takes place prior to each JPC Meeting to agree an Agenda. Such a meeting took place on 5<sup>th</sup> May, 2016 at which the Agenda as circulated was agreed.

#### Item No. 3: Co-Ordination of Plans.

Mr. Brian Tyrrell reminded Members of the full complement of the Joint Policing Committee as outlined in the JPC Guidelines, six members to come from the Community Sector. A formal request to be submitted to PPN for representation on the Joint Policing Committee.

Mr. Tyrrell then outlined the hierarchy of Plans that the JPC must feed into and suggested that the Committee form a sub group to draft a JPC Six Year Plan and JPC Annual Work Plan with consideration given to the objectives of the Policing Plan and Local Economic and Community Plan. This group could be assisted by a member of staff in the Community Development Section of the Council and a member of An Garda Síochána.

# Item No. 4: Road Safety Strategy

Mr. Frank Stafford circulated the Council's Road Safety Plan to all those present at the meeting and gave a briefing on the Plan. Members commented and raised queries on the following issues:

- 30 km Speed Zones.
- Road Safety Signage in Housing Estates.
- Transport Infrastructure Ireland Road Markings.
- Request a representative from TII to attend and address the next JPC Meeting.
- Review of Traffic Signs Manual.

Ms. Maria Melia and Mr. Frank Stafford responded to queries raised in relation to the above.

## Item No. 5: <u>County Speed Limit Update</u>

Mr. Declan Murphy gave an update on the review process currently being carried out over the last number of months, progress to date and time lines going forward.

Members thanked Mr. Murphy for the update and complimented the works carried out to date. Mr. Murphy responded to further queries raised.

#### Item No. 6: The Policing Authority – Submission for Draft Strategy Statement.

Cllr. McKee informed the meeting that all Chairs of the Joint Policing Committees across the country have been invited by the Policing Authority to attend a meeting on the Authority's Draft Strategy Statement and he will be attending and report back to the Committee on the outcome.

The Chairman also informed the meeting that he received a request from Age Friendly County Group expressing interest in a representative joining the Joint Policing Committee to which he advised the group to make their application through the Public Participation Network.

#### Item No. 7: Any Other Business

Detective Inspector Derek Hughes gave a presentation to the meeting on Crime Reduction which included details regarding the following:

- Kilkenny Divisional Crime Priorities 2016.
- Burglary levels in Kilkenny and Control Measures implemented.
- Reasons why there is a reduction in burglary figures.
- Core Pillars Project Storm.
- Social Media Engagement.
- Victim Support.
- Roads Security Checkpoints.
- Partnership with N.R.A.

All members welcomed the presentation and complimented the work being carried out by An Garda Síochána. It was requested that a copy of the presentation would circulated to all Members.

In addition, Members commented and raised issues in relation to the following items:
