(c) Tithíocht - Housing

(i) Draft Right to Reside Policy.

Mary Mulholland referred to the Draft Right to Reside Policy document as circulated and advised that the document has been drafted and agreed by the Housing SPC and is now before the Elected Members for adoption. This policy will address the need for a closer oversight of tenancies in order to deal with the increasing number of Ant-Social Behaviour incidences in Council properties. The local authority has worked hard in the last two years to increase its activity in dealing with anti-social behaviour and as part of the increased activity in tenancy management, it has become clear that tenancies where the occupants are not known are more difficult to manage. Mary Mulholland went through the various scenarios that arise in relation to occupancy in Council houses and this has become difficult to manage by our Housing Section. The implementation of this policy will result in better tenancy management and provide clarity to tenants.

(ii) Draft Succession Policy

Mary Mulholland referred to the Draft Succession Policy document as circulated and advised that the document has been drafted and agreed by the Housing SPC and is now before the Elected Members for adoption. The adoption of a policy on succession of tenancy will make it clear for people when a succession of tenancy is eligible for and when it is not, to avoid undue stress for people and to allow the housing office to better manage its public housing stock, which must be retained to meet the requirements of households in the greatest need of assistance.

It was proposed by Cllr. Eamon Aylward, seconded by Cllr. Michael Doyle and agreed that:

"the "Succession Policy" is hereby approved by the Members of Kilkenny County Council".

Cathaoirleach, Cllr. Michael Doyle, thanked the Housing Department and Housing SPC for their work in preparing both these policy documents and bringing them to the Members for approval.

(d) Pobal Cultúr - Community & Culture

(i) Community and Cultural Facilities Capital (CCFCS) Grant Scheme 2023

It was proposed by Cllr. Mary Hilda Cavanagh, seconded by Cllr. Andrew McGuinness and agreed that:

"That the Community and Cultural Facilities Capital (CCFCS) Grant Scheme 2023 is hereby approved by the Members of Kilkenny County Council."

Mary Mulholland introduced Michelle Colclough, Civil Defence Officer, to the meeting and acknowledged the work of Michelle and her team.

Michelle Colclough gave a presentation to the meeting on the activities of the Civil Defence Team from January this year to date.

Cathaoirleach, Cllr. Michael Doyle, thanked Michelle for her presentation and her team for the work they do and particularly mentioned the work the Civil Defence Team did during COVID, flooding in Inistioge and at community events across the County.

(i) Climate Action Update

Dearbhala Ledwidge, Climate Action Officer, thanked the Elected Members for the opportunity to give an update on Climate Action Plan. She advised that there are now 3 no. team members in place with a 4^{th} member due to commence shortly.

- Preserved and Predicted Climate Impacts in Ireland.
- Kilkenny County Emissions.
- What can the Council do to bring down emissions.
- Scope of LACAP (Local Authority Climate Action Plan).

- Kilkenny City Decarbonisation Zone.

- Lead Authority for PLEEP (Public Lighting Energy Efficiency Programme) which involves replacement of 75,000 public lights across the region with LED lights.
- New Senior Engineer employed to lead on European Investment Programme for LAWPRO.
- €50 million EU Investment Programme to implement improved water quality.
